Purpose of Report

This report seeks your approval to establish a co-educational Year 1 - 8 full primary school at Burberry Road, Drury, Auckland, intended to open in Term One, 2022.

If established the school will incorporate a special education off-site unit to be operated by Parkside School.

Summary

- Drury is the largest and fastest growing area of residential development in Auckland. Ministry of Housing and Urban Development advice from March 2019 indicates a Drury population of 65,000 people by 2043, including approximately 11,350 children around 6,800 primary students and 4,550 secondary students.
- A 10 year growth plan for this area is included in the National Education Growth Plan (NEGP). The growth plan anticipates that there will be additional capacity required across all year levels and the establishment of four to six primary schools and one or two secondary schools.
- The Ministry owns a 4.7 hectare site in 41 Burberry Road, Drury and we recommend establishing a primary school on this site to cater for the anticipated increase in students.
- 4 Consultation regarding the establishment of Drury West Primary School has been carried out according to Section 157 of the Education Act 1989 with schools whose rolls might be affected. No responses were received to the consultation undertaken.
- We also consulted NZEI Te Riu Roa, which supports the establishment of a state nonintegrated full primary school in this area.

- Funding for a new primary school in Drury West was announced in June 2017. This was part of a \$240m package to provide further capacity to meet roll growth in Auckland.
- We recommend the establishment of a new primary school (Years 1-8) at 41 Burberry Road, Drury, due to the substantial school-aged population growth in the area. If you agree, Drury West Primary School is expected to open for instruction at all year levels in 2022.

Recommended Actions

The Ministry of Education recommends that you:

a. **note** that on 7 August 2019 you approved consultation under section 157 of the Education Act 1989 on the proposed establishment of a new Year 1 – 8 primary school in Drury West Auckland, and that consultation has been completed on your behalf;

Background

- 1. Drury West Primary School is a proposed new primary school to be located in the South Auckland suburb of Drury. The school is recommended due to the substantial residential developments in the Drury area.
- 2. You agreed to consultation on establishment of the proposed school on 7 August 2019 [METIS 1200436 refers]. Under section 157 of the Act we have consulted on your behalf with the boards of trustees of all state and state integrated schools whose rolls might be affected by the establishment of the proposed school.

Network Considerations

- 3. A 10 year growth plan for this area is included in the National Education Growth Plan (NEGP). It is anticipated that additional capacity will be required across all year levels in Drury, and that this will require the establishment of four to six state primary schools and one or two state secondary schools.
- 4. This area has been closely monitored for some time. The Auckland Unitary Plan earmarked Drury, and specifically the area to the west of the current Drury Township (known as Auranga), for significant urban growth in the short to medium term.
- 5. In 2016 it was anticipated that the proposed developments would generate an additional 5,700 students in the wider Drury area. Planning then commenced for both a primary (Year 1-8) and a secondary school in the Drury West area. Ministry of Housing and Urban Development advice from March 2019 indicates a Drury population of 65,000 people by 2043, including approximately 11,350 children around 6,800 primary students and 4,550 secondary students.
- 6. The Auranga Development, located west of Drury township, will provide up to 2,650 mixed urban residences contributing to the wider Drury area that could potentially be New Zealand's fifth largest city with a population exceeding 130,000 within 30 years.
- 7. Currently the Drury area is served by two primary schools, Drury School and Ramarama School. Through Budget 2019, Drury School will be provided with six classrooms to increase its capacity, bringing its total teaching spaces to 25.

Enrolment scheme

- 8. Should you agree to the establishment of the school, an enrolment scheme will be developed as the projected population growth presents an ongoing risk of overcrowding without a scheme.
- 9. As with all new schools we will work closely with the establishment board of trustees to ensure the proposed home zone will meet the new school's needs so that it is viable, as well as ensuring that the impact on existing schools in the network is managed.

Proposed new school

- 10. It is proposed that the new school will be a co-educational Year 1 8 full primary school located at Burberry Road, Drury, South Auckland.
- 11. The school will initially be known as Drury West Primary School and it is anticipated that it will open for tuition at the start of 2022.

11. An initial build for 370 students is proposed, with master planning for a roll of 700 students. There will also be a special education satellite unit of Parkside School included in the development.

Satellite unit of Parkside School

- 12. Parkside School is a day special school that has a base site in Pukekohe, a network of satellite units in local schools and a transition programme in the Pukekohe community for students 18 21 years.
- 13. The distribution of students currently enrolled at Parkside School is concentrated in the Pukekohe area and extends west to Glenbrook, east to Ramarama and north to Papakura.
- 14. Parkside School's satellite network is currently operating at 94% capacity and the growth projected for Drury means that additional provision will be needed. The teaching space has been incorporated into the build plan and budget.
- 15. The board of Parkside School will need to enter into an agreement with the Secretary for Education before the unit begins operation.

Consultation

- 16. Under section 157 of the Education Act 1989, you are required to consult with all state schools whose rolls might affected before establishing a new school. You gave permission for the Ministry to undertake this consultation on your behalf on 7 August 2019 [METIS 1200436 refers].
- 17. We consulted with 17 schools. We also contacted the two closest schools (Drury School and Ramarama School) to the proposed school by telephone. No responses were received to the consultation undertaken.
- 18. We also consulted NZEI Te Riu Roa, which supports the establishment of a state non-integrated full primary school in this area.

Property

- 19. The Ministry has purchased 4.73ha off 41 Burberry Road and Bremner Road, Drury, for the new school.
- 20. The site has been designated for Year 1 8 education and early childhood education provision.
- 21. The Drury West design scope will be consistent to Ministry design principles, embody flexible learning environments, provide opportunities for efficient construction approach, deliver value for money and have low maintenance and running costs. The design scope will include spaces allocated per the School Property Guide, outdoor learning spaces and associated open space and landscaping, and also include a special education satellite unit of Parkside School.

Financial Implications

22. Funding for a new primary school in Drury West was announced in June 2017. This was part of a \$240m package to provide further capacity to meet roll growth in Auckland.

Transport Implications

24. There are no identifiable substantive transport implications associated with the establishment of the school, given the public transport available in this area.

Establishment Board of Trustees

- 25. Every new school has an Establishment Board of Trustees (EBoT). Nominations were sought for the EBoT, subject to your agreement to establish the school, while the section 157 consultation was underway.
- 26. The process of appointing the EBoT has been delegated to the Ministry. Once nominations have been assessed against the criteria for appointment, appointments will be made under section 98(1)(a)(i) of the Act.
- 27. Should you agree to the establishment of the school, we will also commence the appointment process for a Governance Facilitator to support the school to become an effective governance body and to prepare the school for opening as an effective learning organisation.

Risks

- 28. There is a risk that the population growth projected for this area will occur more slowly than forecast and that the school will not be fully utilised for some years. However, this risk is considered to be very low as work is currently underway in the Auranga Development.
- 29. We will continue to monitor demographic growth in this area in order to respond to future residential developments and population growth.

Next steps

- 30. If you approve this establishment, you are asked to sign the attached letters to local MPs (Annex 1) and Parkside School Board of Trustees (Annex 2), and the *New Zealand Gazette* notice (Annex 3).
- 31. You are also asked to issue a media statement (draft attached as Annex 4).
- 32. An EBoT will be appointed, and a governance facilitator appointed to support the EBoT as it works to ready the school to open in 2022.
