Thank you for your email of 23 February 2018 to the Ministry of Education requesting the following information:

- Can you release the details of the 15 (ECE) organisations that did not meet the regulatory requirements and licenses were cancelled.
- Also, more specific details around why health and safety concerns, lack of appropriate space and facilities, and management and administration issues.

This request follows on from your initial request on government funding for Early Childhood Education (ECE) services me ngā kōhanga reo.

Your request has been considered under the Official Information Act 1982 (the Act).

As previously advised, a provisional licence is issued when an early learning service isn't meeting our standards. A provisional licence is not the only option and consideration will be given to the severity of the situation, the immediate risk to health and safety of children and the number of potential regulatory breaches (non-compliance with regulations). A provisional licence tells the service, staff, parents and communities what improvements need to be made. When a service is placed on a provisional licence our staff work with the service provider to resolve issues, we monitor the service closely and set deadlines for improvements.

In most cases services do make the required improvements, and at any one time less than 2% of the country's 4,636 early learning services are on a provisional licence. Where a service does not improve, we cancel their licence and close them down.

Please find attached a table of the names of ECE organisations that had licences cancelled and the details why as **Appendix one**.

The reasons for licence cancellation for three ECE organisations have been withheld under section 6(c) of the Act, as to release this would prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial.
