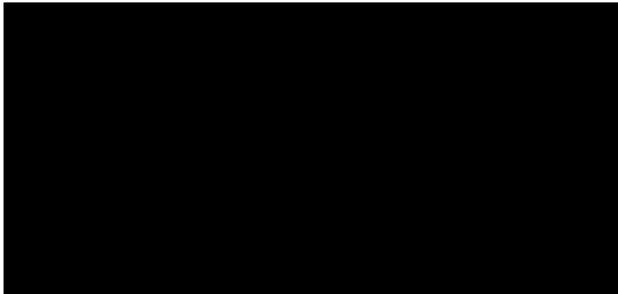

Thank you for your email of 8 June to the Ministry of Education requesting the following information:

1. *In the last two years, broken down by year, how many requests for information under the act were:*
 - *denied in full*
 - *granted in part*
 - *granted in full*
2. *When refusing or partially refusing requests, what is the reason provided most often?*
3. *How many responses have been extended beyond the 20- day deadline?*
4. *On what subject / topic is information most regularly requested?*
5. *On how many occasions have responses to requests been reviewed by the Minister before being released?*

Your request has been considered under the Official Information Act 1982 (the Act).
I respond to your requests below:

In the last two years, broken down by year, how many requests for information under the act were denied in full, granted in part, granted in full?

The Ministry of Education is required to comply with the provisions of the Official Information Act (OIA) 1982 which amongst other things, specifies timeframes for responding to requests.

The Ministry takes its obligations seriously, and works hard to deliver responses as quickly as possible. The Ministry's Output Plan provides measures for the provision of information in relation to factual accuracy, appropriate style, and timeliness and rejection rates. We actively consider each request submitted and in some cases, extensions are required due to the level of consultation necessary or because a large amount of information is requested.

I have provided you with the last six months of data on requests that were denied, granted in part or in full as **Appendix One**. Information prior to this date is not easily accessible as the Ministry's systems did not previously capture the details you are seeking.

To obtain the information prior to the last six months would require manually sourcing and analysing the data associated with each of the close to 1000 OIA responses within scope of your request.

This part of your request has therefore been refused under section 18(f) of the Act, as this data cannot be made available without substantial collation and research.

When refusing or partially refusing requests, what is the reason provided most often?

The Ministry has not previously captured the information you seek, however more recent data shows that common reasons include protection of the privacy of individuals, maintaining the ability to provide free and frank advice and maintaining constitutional conventions.

How many responses have been extended beyond the 20- day deadline?

As mentioned previously, the Ministry aims to respond to all OIA requests as quickly as possible. In some cases, we are required to extend response timeframes in order to complete consultations or because of the size of the request.

Appendix One includes information about response extensions for the last six months. Information prior to this date is not easily accessible as the Ministry's systems did not previously capture the details you are seeking.

As such, the remainder of this part of your request has been refused under section 18(f) of the Act, as this data cannot be made available without substantial collation and research.

On what subject / topic is information most regularly requested?

Common topics include:

- Property
- Fees free education
- Partnership Schools
- School Transport
- Reviews currently underway across the education sector

On how many occasions have responses to requests been reviewed by the Minister before being released?

The 'No Surprises Convention' is set out in the Cabinet Manual and requires departments to inform Ministers promptly of matters of significance within their portfolio responsibilities, particularly where these matters may be controversial or may become the subject of public debate. On this basis, there are occasions where our Ministers or their offices are provided with copies of the Ministry's Official Information Act responses.

Information on the number of OIA's reviewed by the Minister is not captured. To collect this information would require us to manually source and analyse the data associated with each of the close to 1000 OIA responses within scope of your request.

This part of your request has therefore been refused under section 18(f) of the Act, as this data cannot be made available without substantial collation and research.

Proactive release

The Government's desire for transparency is being realised not only through the release of documents under the Official Information Act but through the proactive release of documents that support Ministers' decision making.

Relevant papers are considered for proactive release on the Ministry's website following the Minister's approval of the paper. This is to ensure information that is of public interest is made available as soon as possible.

The proactive release of these papers supplements the wide range of information already released by the Ministry including the publication of Official Information Act responses, information specific to significant announcements, statistical information on Education Counts and corporate publications.


